This landmark victory, in the face of a vigorous defense by the City, preserved important individual property rights and revived affordable accommodations. He is also counsel of record in numerous <u>wrongful death</u>, <u>personal injury and property damage cases filed against Southern California Edison</u> and various public entities stemming from the Thomas Fire and Montecito Mudslides. These "mass tort," complex civil litigation cases are <u>pending in Los Angeles Superior Court as the Southern California Fire Cases</u> (Judicial Council Coordinated Proceeding No. 4965).

In addition, Mr. Logue is routinely engaged by ultra-high net worth clients with a variety of real estate holdings, from office buildings and apartments to ranches and luxury estates. Transactional clients appreciate his strong litigation practice and background in dispute resolution, along with his specific experience navigating challenges faced by real estate owners on the Central Coast.
